Sir/Madam

In terms of Section 14 the NCTE Act, 1993, the **SRI RAM TIRTH CHAUDHARY MAHAVIDIYA, VILL.-IMILA BANGHUSRA, POST-REHRA MAFI, TEHSIL-UTRAULA, DISTT.-BALRAMPUR, UP.** has submitted an application (Code No. APN07747) to the NRC for grant of recognition / permission for conducting B.ED course of one year duration with an annual intake of 100 students at **SRI RAM TIRTH CHAUDHARY MAHAVIDIYA, VILL.-IMILA BANGHUSRA, POST-REHRA MAFI, TEHSIL-UTRAULA, DISTT.-BALRAMPUR, UP.**

2. On the basis of scrutiny of the documents submitted by the institution the documents attached therewith, input received from the Visiting Team Report and video graphy along with related documents, the NRC in its 148th meeting held on 28-30 August, 2009 is satisfied that the above institution has adequate financial resources, accommodation, library, laboratory as prescribed in the norms and standards and that it fulfills all such other conditions relating to infrastructural and instructional facilities required for proper functioning of the institution for a teacher education course and the committee **decided to issue letter of intent prior to recognition under clause 7(9) of regulation 2007**

3 Before grant of formal recognition under Regulation 7(11) is considered, you are requested to submit the following: -

- (i) The institution shall make appointment of faculty/staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. An Affidavit on the prescribed format (Format enclosed) on Rs. 100 stamp paper from the Management of the institution is required to be submitted.
- (ii) The institution shall launch its own website covering, *inter alia*, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure (land, building, office, classrooms, and other facilities/amenities), instructional facilities (laboratory, library etc.) and the particulars of their proposed teaching and non-teaching staff etc. with photographs. The details of the website may be submitted.

(iii) The institution is required to submit evidences regarding no. of titles of books in the library as per NCTE norms.

4. Admission shall not be made until formal recognition order under Para 7(11) of the Regulations dated 10th December 2007 is issued by the Northern Regional Committee, NCTE and affiliation is obtained from the examining body.

5. You are advised to comply the above requirement before formal recognition is considered under Regulation 7(11) within 21 days from the date of issue of letter of intent.


